PDWG CHAIRS

The PDWG Chairs are :-

- Perform the administrative functions of the PDP
- Act as Moderators on the RPD Mailing List
- Determine whether consensus has been reached within the Community of Policy proposals under discussion.

PDWG CHAIRS

The PDWG Chairs are :-

- chosen by the AFRINIC community during the Public Policy Meeting
- serve staggered two-year terms.
- The term ends during the first Public Policy Meeting corresponding to the end of the term for which they were appointed.
- A term may begin or end no sooner than the first day of the Public Policy Meeting and no later than the last day of the Public Policy Meeting as determined by the mutual agreement of the current Chair and the new Chair.

PDWG CHAIRS

- If the Working Group Chair is unable to serve his or her full term, the Working Group may select a replacement to serve the remainder of the term.
- If the Working Group Chairs are unable to attend the Public Policy Meeting, the Working Group shall nominate a Chair for the session.
- Anyone present at the meeting, whether in person or by remote participation, may participate in the selection process for a temporary Chair.

PDWG CHAIRS

- **No PPMs were held since June 2022**
- **PDP does not provide guidance as to the tenure of the PDWG Chairs in such exceptional circumstances**
- **Business continuity on PDP matters is critical**
- **AFRINIC anticipates a revival of its PDP so that challenges and issues experienced .**
- **PDWG Chair selections will happen in line with established procedures**

PDWG CHAIRS

Temporary solution to ensure business continuity as well as accompany the PDWG in its revival of the AFRINIC PDP

The outgoing PDWG Chairs to oversee the AFRINIC-36 PPM . We have sought their agreement.

Community has expressed their views on the Mailing List with potential solutions to address the problem.

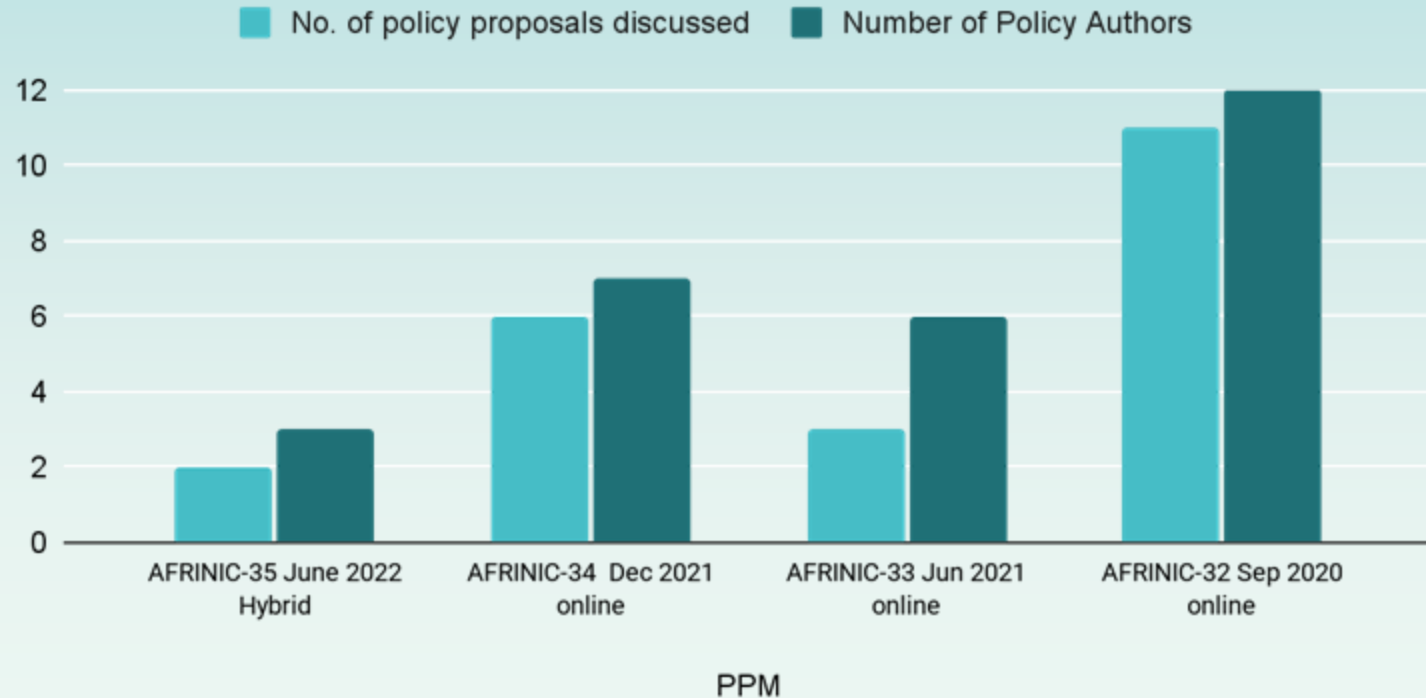

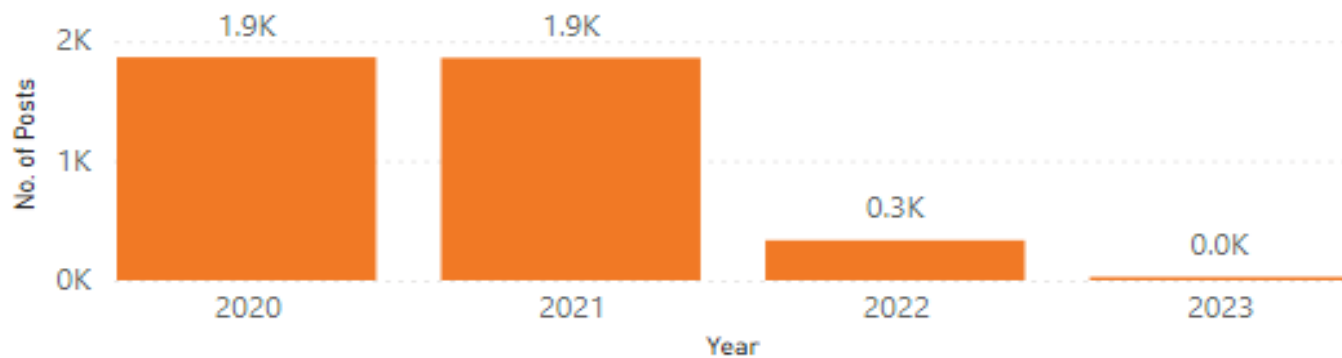
No. of policy proposals discussed and Number of Policy Authors



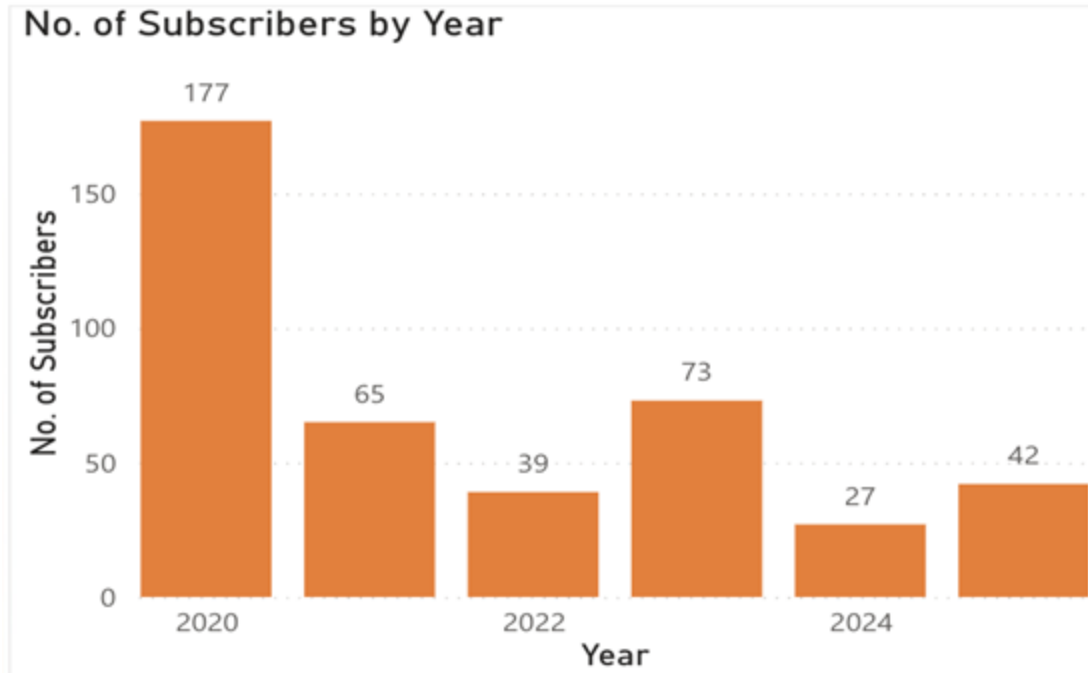
Trend in Active discussions on RPD Mailing List

No. of Posts

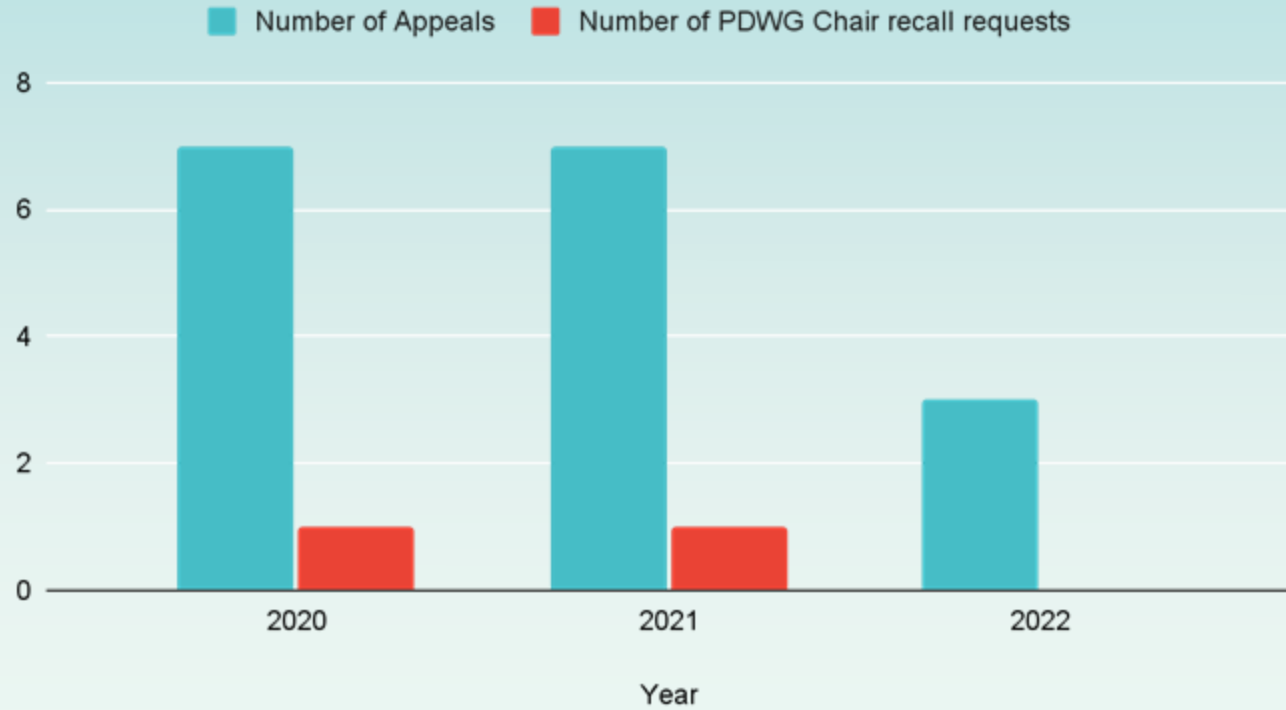

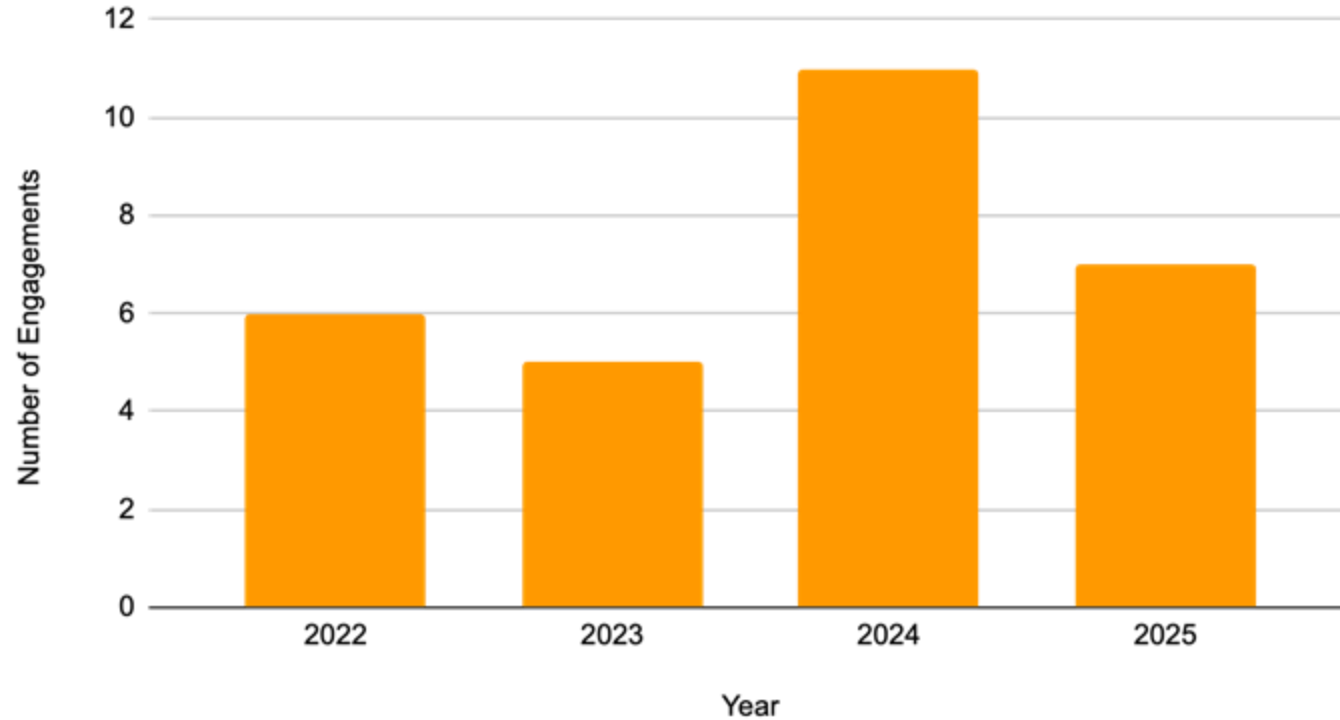
Cloud Innovation Ltd vs AFRINIC, Application for injunction – ref Resource Transfer Policy -

ICP-2 Review/Draft RIR Governance Document

The second consultation on the revised draft “Governance Document for the Recognition, Operation, and Derecognition of Regional Internet Registries” (RIR Governance Document) intended to replace Internet Coordination Policy 2 (ICP-2) has officially concluded on 7 November 2025

The feedback will be used to determine whether further amendments and community consultation are required as part of the process to update ICP-2.
